**GENERAL INSTRUCTIONS**

**PRODUCT INFORMATION**

This product is not suitable for use as a standalone termite management system for an entire structure. HomeGuard® sheeting products (DPC, Blue and TMB) when used in conjunction with HomeGuard® Collars and HomeGuard® GT are intended for use as a complete Termite Management System.

**Caution:** Use only in well ventilated areas.

**APPLICATION**

Cut the seal at the top of the cartridge. Cut the nozzle end to desired opening (approx. 5 mm diameter). Fit to the top of the cartridge.

**Drying Time:** Skins immediately, maximum toughness achieved over several days.

**Clean Up:** Turps. Remove dried sealant from skin by gently rubbing with petroleum jelly.

**Notes:** May damage some plastics e.g. polystyrene, polycarbonate. Not for permanent water immersion. When cold, store at room temperature for easier use.

**STORAGE AND DISPOSAL**

Store in closed original packaging, in a cool, well ventilated dry area away from children, animals, food and feedstuffs. **DO NOT** allow cartridges or packing to get wet. **DO NOT** store for prolonged in direct sunlight.

**DO NOT** store HomeGuard® Termiflex in high temperature areas such as utility boxes or tool boxes that are subject to direct sunlight. If this product is exposed to high storage temperatures it may ruin the integrity of the cartridge and/or plunger. Dispose of empty cartridge by wrapping in paper, placing in a plastic bag and putting in garbage.
